ENSURING LONGEVITY FOR THE VILLAGE OF MARTIN'S ADDITIONS *Notes from the First Chairman*

As we approach the official date of municipal incorporation of the Village of Martin's Additions, Chartered almost 100 years ago and established 30 years ago, we turned to its first Chairman, Paul Weller at 3411 Raymond Street for his reflections. Paul still resides at the same address.

The early 1980's was a watershed period for the seven-decade old Village of Martin's Additions. Elected council members each gave up their \$40/month stipend to hire a Village manager, renewed efforts were being made to protect the valued tree cover, and street and sidewalk improvements were made into a special priority.

At the same time, there was increasing concern that the bucolic self-control could not last. As a special taxing district, the Village could become a takeover victim of an aggressive county government in a fast-growing population center. Neighboring Sections Three, Four, and Five had already made the move to full incorporation, which made them entities with permanence like Rockville and Baltimore. Their leaders provided invaluable counsel to the Village.

The Village council took up the challenge. We had a unique ace-in-the-hole on Brookville Road: long-time resident Neal Potter, who was a veteran member of the County Council, soon to become County Executive. We sought his advice and support, and he readily gave it. We also had two valuable legal resources: council member Mike Zielinski and outside legal counsel Roger Titus, now a federal judge. They assisted the Council in drafting a new Village charter to replace the original 1916 document.

Council members went into action mode, first appointing a three-member Committee on

VILLAGE COUNCIL MEETING

March 19th at 7:30 PM. Village Office Please note the April Meeting, which will include the Candidates Forum and Discussion of the Budget and Tax Rate for FY 16, has been advanced one week from the usual schedule and is now set for **Thursday April 23rd.**

Incorporation, then preparing a referendum to determine depth of support from the Village's nearly 1,000 residents. Village volunteers stepped up to go door-to-door with petitions. Following overwhelming approval of the idea of incorporation, the Village's Neal Potter went to his fellow County Council members, as well as to State Delegate Don Robertson, a resident of Section Three to obtain the necessary approval of both the County Council and State Legislature. With approval from both legislative bodies, it came back to Village voters to make the final vote of approval.

The Village of Martin's Additions was officially incorporated on March 19, 1985. It really took a "village" to accomplish the nearly five-year process. Assistance was required from both residents and non-residents. In later years, support for local incorporation waned from elected officials, as adjacent Rollingwood found when it was recently rejected for its own incorporation petition. Martin's Additions is most fortunate.

2015 VILLAGE ELECTION PROCESS KICKED OFF



Beginning Monday March 2nd nominations for the Village Council will be accepted by the Village Elections Committee. This year, three seats are open for election to the Village Council. Each seat is for a two-year term. Terms for Josh Bowers, Bill Lebovich and Jon Fleming expire June 30, 2015. Please see the enclosed nomination form for your use, should you wish to nominate yourself or a neighbor to be a candidate for the Village Council.

Would you like to serve as a Council Member? Martin's Additions is a self-governing, incorporated municipality in the State of Maryland. As such, the Village is responsible for providing trash collection, recycling, road and sidewalk repair, snow plowing, construction permitting and other municipal services. The smooth function of government and delivery of services have depended on the ability and willingness of interested residents to serve on the governing body—the Village Council. Would YOU like to be involved? Consider becoming a candidate.

Who can be nominated? Any resident of Martin's Additions who is a qualified voter (18 years old as of Election Day, May 14) may nominate another qualified resident or him - or herself.

How do you nominate a candidate? Nominations must be made in writing and sent to the Election and Ethics Committee, c/o Village of Martin's Additions, 7013B Brookville Road, Chevy Chase, MD 20815. Nominations open on Monday March 2nd and close on April 2, 2015. A nomination form can be found on the next page.

What do I have to do if I am a nominee? If you have been nominated you will need to accept or turn down that nomination to the Election Committee by April 2, 2015. Final Candidate Statements and bios are due to Village Office Thursday, April 9th. Candidates will be welcomed to a Candidates' Forum at the April 23rd Council Meeting where they will be able to give brief statements and answer questions.

When is the election? Thursday, May 14th along with our annual Celebration on the Sidewalk and prior to our Annual Village Meeting.

The Election 2015 Plan presented below reflects a consultation with the Charter requirements, a cooperative holiday schedule this spring and agreement of the Election and Ethics Committee. The recommended schedule for Village Elections and Annual Meeting, 2015, is as follows:

- **Monday March 2, 2015—Nomination period opens**—Elections and Ethics committee will begin accepting nominations for candidates for the three open Village Council seats. Terms expiring for: Josh Bowers, Jon Fleming, Bill Lebovich. Notice published; announced on website.
- **Sunday March 15, 2015 - VMA Incorporation Celebration.** Opportunity to announce the opening of the nomination period. Elections and Ethics Committee will include a “Community Civic Engagement” component of this event for all residents to generate interest and community involvement and inspire some folks to serve on the Village Council.
- **Thursday April 2, 2015—Nominations close.**
- **Thursday April 9, 2015—Final Candidate Statements and bios due to Village Office.**
- **Thursday April 23rd, 2014—Candidates’ Forum** at the April Village Council meeting.
- **Public Notice by mid-April [by May 1st at the very latest]** Martin’s Edition Newsletter containing slate of candidates and their bios and statements and election information will be published mid-April to arrive in residents’ mailboxes no later than May 1st, as required by the Village Charter (no later than 2 weeks before the election); names of candidates, proposed budget and notice of proposed tax rate must be included in that notice/newsletter along with notice of polling place and time.
- **Thursday, May 14th, 2015—Village election and annual meeting** (Charter requires election to take place between March 1st and May 15th each year). Time of Election: 5-7:30 PM

INCOME TAX TIME... DON'T FORGET WHERE YOU LIVE



As a municipality in the State of Maryland, the major source of revenues for the Village of Martin’s Additions is our share of income taxes which every resident pays to the state. In order for us to receive this revenue sharing, you must write **“Martin’s Additions”** in the box marked “City, town or taxing area” on your Maryland Income Tax Form 502. This assures that a portion of your tax dollars comes back to the Village (as provided for in State law) to deliver services. This money helps support our municipal budget for trash collection, recycling, leaf collection, street cleaning, snow removal, tree care, and the many other municipal services that are

administered by the Village of Martin’s Additions. Don’t give those revenues away! You have much more control over how these tax dollars are spent right here in your Village and for your direct benefit.

MLK DAY BOUNTY GETS THE VILLAGE FOOD DRIVE OFF TO A FANTASTIC START!

It may have been chilly on this year’s Martin Luther King Jr. Day of Service but the response to the Martin’s Additions-Manna Food Drive was heart-warming! Villagers and Brookville Road shoppers filled five large boxes with nonperishable items, and in Section 5, kids going door-to-door collected at least that much – all of it delivered to our Village and then driven the next day to the Manna Food Center’s main facility in Gaithersburg. The load weighed in at 392 pounds; combined with after-holiday donations, our January total reached 626 pounds – a great start to the year! In addition, MLK Day cash donations were \$284, which will be spent this month on even more food to fill warehouse shelves.

Special thanks go to our intrepid troop of volunteers: Devin and Ethan Cohen and their mom Laurie on Turner Lane, along with friends Lola and Tyler Nordlinger and their dad Dean, a bit down Brookville Road on Curtis Street; Nayerra Haq on Shepherd Street; and Pamela Sacks, also on Turner Lane. Thanks also to Marilyn and Tim Hanlon, who organized the Section 5 kids and then delivered the vanload of donations.

Of course, our food drive continues throughout the year to help Manna meet its goal of “fighting hunger and feeding hope” in Montgomery County. Monthly, Manna supplies some 3,300 County families certified as being in need with 70 pounds of emergency and supplemental food. In addition, it provides Friday backpacks to elementary school kids who might otherwise go hungry on weekends and also helps low-income senior, disabled and homeless residents.

So please drop your donations at any time in the box at the foot of the stairs to the Village Office, 7013-B Brookville Road, or on the front porch at 3406 Turner Lane. And many, many thanks to all of you who continue to give so generously.
